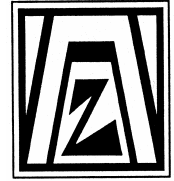

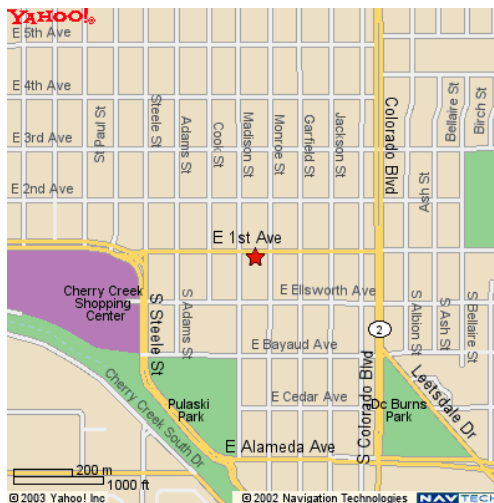
### Meal Choice

Thought you would like to hear about the first Area Meeting held in Colorado this past weekend. The weather cooperated and allowed several hardy travelers to make the trek to the Area 4 Meeting hosted by the Zonta Club of Prowers County in Lamar, Colorado.

The Friday Night Social allowed us to renew prior friendships and meet new members, while catching a glimpse of the young talent comprising the square dancers of Denim and Lace (appearing this coming weekend at the National Square Dancing Competition in Denver).

On Saturday we were surprised at the enthusiastic turnout and

we just don't know how the Zonta Clubs around the country find such lively and diverse speakers. Who would have ever thought that tiny Lamar would have not one, but two, talented woman speakers. Cheryl Sanchez, a Business Instructor and Counselor for Lamar Community College has several pocketfuls of "real life experiences" and spoke to us about the "Power of One". And later, Dr. Leah Borstein, Academic VP of Lamar Community College, spoke to us regarding her year of working and living in the United Arab Emirates. Dr. Borstein has traveled to or resided in 29 different countries, including Africa, Central/South America, Europe and the Middle and Far East. Can you visualize Jacki Sammons in a Burka?

The reports from the Area 4 Clubs were impressive. Just when you think there are no new fund raising ideas out there, you are given the opportunity to see and hear how the power of not one, but many, Zonta Clubs, can come together and make significant improvements in their communities.

- \* The Canon City Club has started "Sharon's Closet" in honor of one of their past members and working with the national Dress For Success organization. The idea for their Art Show being held in September, came from our own Club's past successful effort.
- \* The Pikes Peak Club worked with their local Soup Kitchen giving volunteer hours and donating money to their Halfway House and At Risk Girls Center.
- \* Prowers County worked on domestic safety issues and used a District 12 idea and sold advertising and then calendars to businesses for distributing as advertising.
- \* The Pueblo Club worked with the State Health and Human Services on bilingual projects; creating an impressive bilingual story book for young girls. Past Zonta member, Anna Taussig, was honored by the YWCA, with the creation of the Anna Taussig Award.

But not content to rest on their laurels, they brainstormed some new concepts:

- ? How about that nudie calendar for the Zonta Club of Denver?
- ? Or donating the men in your life to be auctioned off for a day?
- ? Second Hand Sales can always offer hopes of a hidden treasure or a real bargain.

**Member Moment - Marjorie Pickett presented a tribute to Maryethel's life.** Maryethel passed away February 13 and was interred February 20<sup>th</sup>. A niece, nephew and three cousins survive her. Because her niece and nephew were orphaned, she provided for them. Maryethel's pediatric career spanned 38 years, from 1954 to 1992. She was the first woman pediatrician in Jefferson County. Maryethel was respected as a doctor and was honored by her fellow physicians in elective offices. She also received many awards for her work in pediatrics. She was a true American hero who pioneered the way for other generations of women in the medical field. Maryethel was active in her church. In retirement, she joined not one but three senior citizen groups. She never lost her zest for adventure and knowledge. We were privileged to have her as a member of Zonta.

Smoke Signal Editor, Public Relations Chair (meets with all committee public relations liaisons), Historian, responsible for press releases, working on possibility of web site, archives and files, scrapbooks (10% of membership.)
