

### Fundraising Proposes Three Events: Vote Needed

The Fundraising committee's charge this year was to research and offer a new ZCD 'signature' event. Following the brain-storming session we had in October, the committee conducted additional research on the top ideas and is pleased to offer for your consideration, discussion and vote, the following concepts; High Tea, the Glass Slipper Ball and the ZCD Film Festival.

As a result of the Fundraising Committee's research and analysis, each proposal has been rated on Flexibility, Risk, Complexity and "SPEC." SPEC is the availability of business Sponsorships; the possibility of one or two non-profit organizations to Partner with; the need to hire an Event

Planner for maximum return on investments and public relations; and finally the anticipated likelihood of an enthusiastic Commitment by all ZCD members in time and energy to support the event.

Additional information will be provided at the April meeting, and you will be asked to vote on which event we pursue.

#### **HIGH TEA**

The Brown Palace High Tea would offer a leisurely afternoon tea in downtown Denver. Participants would enjoy tea, scones, garden sandwiches, pastries and music. This first High Tea would be at the historic Brown Palace Hotel. Subsequent High Teas could be held at different historic locations in the Denver area. The Brown offers flexibility for the Tea's site; if there are fewer than 70 participants we will be seated in the Palace Mezzanine overlooking the main lobby. We could also host this event in a private room at no additional charge.

The Brown Palace's historian can present fascinating facts about the people and events during the hotel's history and/or provide guided tours. Tours would cost an additional \$75 per group of 35 or fewer.

Proposed ticket prices: Signature Afternoon Tea: estimated ticket price \$55 to \$65 (includes tea, Palace Historian, 45-50 minute presentation & gratuity.

#### **GLASS SLIPPER BALL**

The GSB is a very high profile, classy event. The event includes a silent auction, sale of "surprise gift packages," a "best of chef" mini event, a "best of floral arrangements" mini event, live band, dancing demonstrations and dancing. It is a black tie optional glitzy event.

The silent auction items and surprise packages are all donated and are 100% profit. The chefs and florists participate at no charge. It is nice, also courteous to present them with small thank you gifts and certificates for the winners. It is great PR for them and us with small dollar outlay.



Dancing demonstrations are presented by well known dance studios. These dance studios can be event Sponsors and will sell tickets to their own clients and business contacts.

The corporate community

needs to be involved and asked to sponsor the event. This approach is a marketing opportunity for them.

The club needs to choose a 501C3 that is aligned with Zonta's mission. We would be able to use their mailing list for support and ticket sales.

The tickets should sell for an estimated \$100 to \$125 each. Based on another Zonta GSB event held in Colorado, we should be able to sell approximately 300 to 400 tickets. Our proceeds are estimated to be in excess of \$10,000.00.

This trademarked event is owned by the Event Planner, and is being successfully staged by other U.S. Zonta clubs.

#### ZCD FILM FESTIVAL

The Film-Festival-as-fundraiser concept is relatively new to the Denver Metro area. Currently there are only a few film festivals being staged and most are directly linked to the Starz Film Institute. A Film Festival has total flexibility in size and format and can be expanded and modified for each annual event based on attendance, business Sponsorship, 501©3 Partners, etc.

Initially, we've discussed having a one or two night event with several films being offered for a flat rate. A variety of films will be offered at the festival; comedies, dramas, documentaries, foreign; the options are almost endless. However, all of the films should have a theme related to our mission and those of our selected 501C3 Partners. This is an opportunity for entertainment, fun, food and drinks, with voluntary participation in film discussion forums.

We have tentatively sounded out a location and 'working' partner for this event, Neighborhood Flix, which is independently owned and operates in the Lowenstein Theatre complex at Colfax and Elizabeth with The Tattered Cover book store, Twist and Shout records and Encore Restaurant. These businesses are very excited about the event and Zonta and have offered their own suggestions ranging from a week-long cultural festival, a roundtable film series with food, and discussions with film experts, all the way to possibly renting the entire facility for a private screening party including dinner, drinks, live music, silent auctions and a chance to meet cast & crews, from the films (a little bling).

Neighborhood Flix is unique because they have their own restaurant with chef and food is meant to be eaten in the three separate screening theatres. The theatre has staged numerous events separately and with the other businesses which enjoy high visibility in the Denver Metro area.

Expenses and profits cannot be realistically estimated without further planning on size and the final event.

Corporate Sponsorships seem to be available based on initial contacts, while 501C3 Partners will need to be chosen by the ZCD membership.

#### **Clarifying Considerations**

The High Tea is unique from the other two concepts because we feel this event would be relatively easy to stage with a high 'fellowship factor.' However, the probable income could be lower, but due to the simplicity of staging this event, we feel the High Tea could be held in addition to one of the other events. Please keep this in mind as you consider all of the concepts.

The other two proposed events are more complex to stage but offer higher rates of return for the higher risk. The Club members will have to seek out <u>SPEC</u>. Based on the committee member's research, we stress the importance of SPEC in the success of any event we select now and in the future.

Based on conversations with all ZCD members, we want the signature event to be:

- aligned with and a showcase for the Zonta mission;
- interesting to women and men and non-Zontians;
- a long-term event that can grow and possibly expand in size and
- a source of positive PR for ZCD in the community and attractive to new members.

Finally, we feel that any of the proposed events need a three-year commitment of support by the ZCD members.



## Minutes: Dinner Meeting March 13, 2008

Call to Order by Nikki Headlee at 6 p.m. followed by the introduction of four guests. Nikki also presented the Status of Women Moment.

Robin Smith presented the Z Rock Award to Linda Rhea for her many contributions to the club.

For the Inspirational Moment Mary Benoit read a poem by an unknown author.

Judy McNerny introduced the guest speaker for the evening – our own Linda Rhea. The program was entitled Why Just Survive When You Can THRIVE?. Since becoming a two-time breast cancer survivor, Linda is dedicating herself to being a motivational speaker for others who are facing this disease. But her ideas can be used by everyone to improve the quality of their lives. Her four key points were -

- 1) Believe in yourself
- 2) Have a support system
- 3) Establish daily practices take care of your mind, body and spirit
- 4) Surround yourself with people you love and tell them.

She expanded on these four points so that "living every day your way creates the life you truly desire."

Nikki asked for and received approval of the February minutes.

Mandy Ziegler said, "We have money." She is working on the quarterly reports and will present them next month.

Judy reported the presence of 22 members tonight plus four guests.

Linda Corssmit reminded everyone to e-mail Robin Smith with their service hours or handwrite them tonight. Service hours should be reported every month to Robin. There are a number of service projects in May and volunteers are needed for the Teen Mom Graduation Party (call Linda Corssmit), the WOW fundraiser (call Carroll Allen), the Delores Project Dinner (call Linda Rhea), and the Excelsior fundraiser (call Carroll Allen).

Diane Twining reported for the Fundraising Committee and Advocacy. She indicated Jacki Sammons mailed off 30 lbs. of cell phones for conversion to emergency phones to be used by women possibly in danger.

Anyone wanting to attend The Little Shop of Horrors at the Boulder Dinner Theater needs to make reservations by 3/27. The committee is researching three different possible signature events – a high tea, a film festival and a glass slipper ball – reports in April.

More items are needed for the gift baskets we will sell at the Area 3 meeting. Judy McNerny said anyone wanting to donate items can deliver them to her home. There are three themed baskets – Rockies, Book Lovers and Gardeners. Items are needed by 4/1.

Diane explained King Sooper cards and how the club can buy them and then resell them to others as a fundraiser. Kathy Hyzer indicated her daughter's athletic clubs made a substantial amount selling these cards. The club agreed to move forward on the sale of King Soopers cards.

Diane reported on the fantastic news of the passage of CEDAW by our legislature. Kay Meyer was the very effective leader of this endeavor

which we hope will be written up in The Zontian. Colorado is the 17<sup>th</sup> state to pass it. Now that this is accomplished the advocacy committee is looking over what can be worked on for the next two years.

Wendy Moraskie explained the tri-fold sign she produced that shows all the service projects the club sanctions. Two new service projects were added plus an estimate of the number of service hours performed so far this year. The goal for the year is 2,000 hours.

Nikki discussed the Area 3 meeting which is April 12th. The club will pay for new members to attend. It is a great way for new members to meet other members and to see how Zonta works outside of our own club.

Kathy Hyzer presented the Nominating Committee report. Nikki asked for additional nominations from the floor for each position and having received none the nominations were closed.

The members voted to pay for both meetings. And the members voted to accept all the other changes which were mostly very minor in nature and just kind of cleaned up the by-laws and rules.

The announcement was made that the May meeting will be the 3rd **Thursday** of the month – **May 15**. The 2nd Thursday of May there will be a fundraising dinner at Metro where our club will, hopefully, have good representation when we present and add our check for \$33,155 to the Metro scholarship endowment fund. **REMEMBER OUR MAY MEETING HAS BEEN CHANGED TO THE 15th.** 

Mary Benoit was the winner of the door prize.

Sheila Davis announced there has been an informal gathering for lunch every Friday which has been expanding.
