#### Women's Rights Are Human Rights

#### How Does the U.S. Compare?

Some of you may have seen an article earlier this week referencing the evaluation by the United Nations (UN) "Working Group on the issue of discrimination against women in law and in practice" of the status of women's rights in the United States (US). There were the usual inflammatory headlines, but as I read the brief article the line that surprised me most was that the women in the US could not believe that we were behind other countries in this area. Therefore I looked up the actual assessment and this is some of what I found.

The UN evaluators were legal experts Eleonora Zielinska of Poland, Alda Facio from Costa Rica, and Frances Raday, an Israeli who grew up in the United Kingdom. They visited Texas, Alabama and Oregon. The summary report which was submitted December 11, 2015 will be followed by a more comprehensive report to the Human Rights Council in June 2016. standards included "Public and Political Representation", "Economic and Social Rights" and "Health and Safety Protections". It was stated that "...in the global context, US women do not take their rightful place as citizens of the world's leading economy, which has one of the highest rates of per capita income." Additionally, the US has not ratified the Convention on the Elimination of All of Forms of Discrimination against Women (CEDAW) and is therefore one of only seven countries that has not done so, including Iran, Somalia and Sudan.

In the area of Public and Political Life women hold 19.4% of Congressional seats and average 24.9% of state legislatures, which are the highest percentages ever in the US. Yet the US ranks only 72nd globally in elected representation by women. Economically, it was noted that women make up nearly half of the work force, with a participation rate of 57%, and that working mothers bring in two-thirds of household earnings. However, they were "shocked at the lack of mandatory standards" as required by international human rights law, particularly as pertains to pregnant and post-natal mothers and persons with care responsibilities. "The US is one of only two countries in the world without a mandatory paid maternity leave for all women workers." The international minimum time for such a leave is 14 weeks. Under the heading, Reproductive Health and Rights they cited the 136% increase in maternal mortality rates in the US between 1990 and 2013. This increase is magnified isolated by income and ethnicity. In addition was the concern regarding easy and affordable access to reproductive rights which is often hindered by an employer's insurance coverage, inconsistent state requirements for health clinics and lack of universal healthcare. The report also notes the 21% gender pay gap, which affects women's income throughout their lives and increases women's pension poverty.

While this is an extremely brief outline of a nine page report, I became aware that I am one of the women who assumed that, although we certainly have a long way to go in achieving equality in the United States, we would be one of the top countries in achieving women's rights. I did not realize how far behind we are in many areas when compared to some other parts of the world. It has certainly made me feel more inclined to strive for what has already been established in some other countries, as well as the ideal.

#### Advocacy Committee

Over the holiday season, members of the Advocacy Committee have been working on the details of the Zonta Wings project. As you may remember, Zonta Wings will provide funding for emergency transportation of victims of human trafficking to a safe place. Mary or Alexis must approve any expenditure and we are requesting basic information about each draw on the funds, such as the type of



trafficking the victim suffered, the mode of transportation, and where the victim will be going. The committee believes the club deserves to know how these funds are being used and plans to make periodic reports about the project, as well as having people at CoNEHT speak directly to the club at a meeting this spring.

Please check out the information on the United Nations Association of Denver website about the UNA film festival on January 31 (see Alexis' article above). All of the films sound interesting, but two stand out for Zonta members.

The first is Driving with Selvi is about Indian women who, "forced to marry at a young age, finds herself in a violent and abusive marriage. In deep despair, she chooses to escape, going to a highway with the intention of throwing herself under the wheels of a bus. Instead she gets on the bus, choosing to live, and goes on to become South India's first female taxi driver." This will be shown at 3:45 pm.

Also intriguing are a short film, Good Muslim Girls, in which a female filmmaker tells about two young Iraqi women whose refusal to wear the hijab is, for them, a matter of human rights, is paired with an hour-long feature, Manislam: Islam and Masculinity, in which the female director wishes to undress Muslim men from their patriarchal heritage. This screening begins at 1:45 pm.

How about a ZCD January outing to the movies? Let me know if you would be interested in seeing either of the films described; perhaps we can get a group together for brunch and a film or a film and dinner! Tickets for non-Denver Film Society members are only \$8 for each movie or you can see all of the day's films for \$25! If you are a DFS member, prices are \$6/film and \$20 for the day.
