Protect Yourself from Identity Theft

- Wear a close-fitting pouch instead of carrying a purse, or carry your wallet in your front pocket
- Don't carry your checkbook, excess credit cards or anything with your Social Security number in public
- Don't give any part of your Social Security, credit card or bank account numbers over the phone, email or Internet, unless you have initiated the contact to a verifiable company or financial institution.
- Request a free copy of your credit report once a year: Equifax, 1-800-685-111; Experian, 1-888-397-3742; Trans Union, 1-800-888-4213
- Cancel all unused credit card accounts appearing in your credit report.
- Call the customer service number for your credit card companies and ask to "opt out" of ALL marketing programs, including unsolicited 'convenience' checks mailings.
- Call 1-888-567-8688 to "opt out" of credit agency marketing lists and reduce credit card solicitations.
- Shred pre-approved credit card offers, and all financial documents, preferably with a crosscut shredder.
- Mail bills to be paid at the Post Office, not in your mail box with the red flag raised or in street corner postal receptacles. Sign up for automated payment plans or pay online.
- Ask your bank or credit union to send new boxes of check to them for you to pick up, not to your home.

What to do if Your Identity is Stolen

Resolving the consequences of identity theft is left largely to the victims. It's important to act quickly and assertively to minimize the damage. In addition to these steps, check out Colorado ID theft web site at:

- File a report with your police, sheriff or district attorney and get a copy of the report for the credit agencies, bank and credit card companies.
- ☐ Cancel each credit card. If your report the loss before the cards are used, you are not responsible for any unauthorized charges. Beware of callers selling credit card protection—you don't need this! Carefully monitor your credit card statements for evidence of fraudulent activity.
- Contact your financial institution and cancel all accounts and PIN numbers. Stop payment on outstanding checks and complete "affidavits of forgery" on unauthorized checks.
- Report the theft to the fraud units of the three credit reporting agencies: Equifax 1-800-525-6285; Experian 1-888-397-3742; Trans Union 1-800-680-7289. Request the credit reporting agencies flag your credit file for fraud, and add a victim's statement to your report, such as "My identification has been used to apply for fraudulent credit. Contact me at (your telephone number or address) to verify ALL applications."
- Ask utility companies (especially cellular service) to watch for anyone ordering services in your name. If you have trouble with falsified accounts, contact the Public Utility Commission.

You are not responsible for losses form ID theft. Your credit should not be permanently affected and no legal action should be taken.



Proposed By-Law Change: Page 43 of our by-laws, Article XI

Board of Directors (insert after Section 5)

Section 6: Mail/Telecommunication Voting. The Zonta Club of Denver Board may transact business by mail, conference telephone call or other communication such as fax or email. Action by any of the above requires a written response from a quorum of the Board and a majority vote of that quorum. If any member of the board requests the matter be decided at a Board meeting rather than the above voting method, the request would prevail.

RATIONALE: This would allow the Board to make decisions between Board Meetings when time is of the essence and assembling the Board for one issue would be very difficult. This will also allow the use of the same quorum as is required at Board meetings.
