Victory for WASP Veterans



In May, Congress approved legislation to continue to allow the ashes of World War II members of the Women's Airforce Service Pilots (WASP) to be interred at Arlington National Cemetery.

During World War II, thousands of women volunteered to serve as pilots for training and transport missions, so male pilots could serve overseas. About 1,100 WASPs served and 38 died during missions. The women were paid less than the men they replaced, and the program ended when the women were no longer needed. WASPs were denied veterans' benefits until 1977. In 2002, Arlington National Cemetery approved military honors and burial of ashes there for WASP veterans, but in 2015 the then Secretary of the Army decided that there was no longer room at Arlington.

Hands of the Carpenter Giveaway



Maria and her new Bravada

Nancy McWhirter, Cynthia Herndon, my husband Richard Edwards and I attended the Hands of the Carpenter car giveaway on May 7th. Held at Cherry Hills Christian Church in Highlands Ranch, this wonderful event featured the presentation of ten vehicles to deserving women and their families. Dan Georgeopoulos opened the program with an explanation of how it works. Vehicles are donated to Hands of the Carpenter. Hands then asks their associates (car dealerships and automotive shops) for help in updating and, in some cases, repairing the cars - getting them in shape to give away. Several non-profit organizations are then asked to recommend women to receive a vehicle.

Representatives from the car dealerships and automotive shops introduced the women they were giving the vehicle to and representatives from the non-profit organization that recommended them came up on stage with them. After the keys to their vehicles were given to them, each woman spoke, telling some of her story and thanking God and everyone who was involved in the process. After that the woman was escorted to her vehicle and she drove away in it.

Last year Hands gave away five vehicles; this year, ten. The cars were lined up in the parking lot of the church, each with a large bow on the hood. The money our club

donated to Hands of the Carpenter this year helped to finance the updating of one of those vehicles. This was a very inspiring event and our club members can be proud of their efforts to raise the money that made our gift to Hands possible.

Hands is grateful to have received the donation of a 2002 Bravada from a single woman, which was then prepared for today by our team at Hands Automotive in partnership with Zonta Club of Denver for Maria to drive home. Most of the low-income single moms and widows, who come to Hands of the Carpenter, have their repairs done at Hands' own shop - Hands Automotive in Lakewood.

Maria was nominated to receive this car today by Sandra Coen, Founding Director of James Resource Network, located in Centennial. James Resource Network's mission is to provide single-parent families quick access to hope and supportive services and attainable housing to achieve family stability and self-sufficiency.

In nominating Maria, Sandra writes, "Owning a vehicle will make a difference in Maria and her children's life by helping to maintain work and school, transport children, and to search for an internship in the Event Industry, which could lead to a permanent position after graduation in 2017."

Maria is a single parent of three daughters and no longer owns a vehicle because her vehicle of 8 years became inoperable. She desperately needs a vehicle to continue her education and work-study at Metropolitan State University of Denver and ProStart (Culinary) activities.

Receiving her new 2002 Bravada will keep Maria and her children on the road to success. Please join Hands as we celebrate this day with Maria and her family.

Amelia Earhart Fellowship

Globally, women make up less than 30 percent of the workforce in physics, computer sciences and engineering, according to a 2014 U.S. News & World Report article.



In an effort to carry out its mission that women have access to all resources and are represented in decision-making positions on an equal basis with men, Zonta International offers the Amelia Earhart Fellowship.

The \$10,000 Amelia Earhart Fellowship was established in 1938 in honor of famed pilot and Zontian, Amelia Earhart. 35 Fellowships are awarded annually to women pursuing PhDs in aerospace-related sciences or aerospace-related engineering.

Since the program's inception, Zonta has awarded 1,508 Amelia Earhart Fellowships, totaling more than \$9.3 million, to 1,079 women representing 70 countries. Fellows have gone on to become astronauts, aerospace engineers, astronomers, professors, geologists, business owners, heads of companies, even Secretary of the US Air Force.

She said that the District 25 Governor and other Zontians from Bangladesh were in Kathmandu to visit some of their ongoing projects and were highly pleased with the work they had done and are still doing for the earthquake survivors:

As for the funds kindly made by your club through the screening of the movie, Jhola, we still have not used the funds. We have decided to use it for the earthquake survivors whose plight is very sad. Many of them are living in temporary shelters and due to rape tape sim, the reconstruction work is moving at the pace of a snail. We are interested to rehabilitate them. So the money will be used for the earthquake survivors. There is a lot to do.

I have asked her to let us know if possible specifically how the funds were used. I hope they are able to do so.

Advocacy Committee

Here is some news from the 2016 Colorado legislative session, as reported by former Senator Betty Boyd on the AAUW Colorado website.



A total of six bills attacking a woman's ability to control her own reproductive healthcare and choices were killed.

Bills affecting women that passed included:

House Bill 16-1438, a bill to require modest workplace accommodations for pregnant workers passed both houses and will be signed by the governor.

House Bill 16-1227, a bill to exempt teen parents and victims of domestic violence from the requirement to provide father's names to the Child Support Enforcement agency as a condition of receipt of child support services passed both houses and has been signed by the governor.

Senate Bill 16-022, a bill to extend the child care assistance cliff effect pilot program to additional counties that wish to participate passed both houses and was signed into law by the governor.

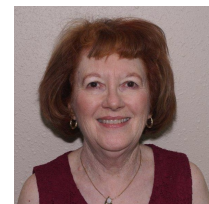
House Bill 16-1260, a bill to extend the statute of limitations on reporting sexual abuse from 10 years to 20 years passed both houses and will most likely be signed by the governor.

In addition, the budget signed by the governor included \$2.5 million to fund a very successful LARC (Long Acting Removable Contraceptive) program in the Colorado Family Planning Initiative. This restores some of the funding cut from the 2015-2016 Budget.

As we all know, the historic Paris Agreement on Climate Change has been signed. As

with everything there is the trickledown effect. UNA Denver will be playing a part. UNA Denver in partnership with Alpha Kappa Alpha Sorority has been awarded a grant from The Better World Foundation to host "train the trainer" workshops for teachers and youth leaders that will serve as a vehicle to educate on relevant climate change actions to promote increased engagement.

On Thursday, April 12, Denver became the 11th city in the US to launch a UNICEF Congressional Action Team (CAT). Supported and trained by US FUND for UNICEF staff, CAT members will engage with their members of Congress to cultivate champions for children.
