IN MEMORY OF DOROTHY



Zonta Club of Denver's long-time member, past president and District 12 past governor, Dorothy Swindt passed away on Monday, April 10. Over twenty Zontians, including six Past District Governors, attended the memorial service held on April 22 to honor her memory. At the service there were copies of a short article about Dorothy that was published in the August 2007 *Smoke Signal*.



The article was written by Beth Mundell, making it doubly poignant. Here is the text of that article--just add 10 years and a couple more great grandchildren!

ONE AMAZING WOMAN....DOROTHY SWINDT

The Scoop:

- Native Coloradan, raised in Torrington, Wyoming (the first state to elect a female governor in the United States, don't ya know!)
- Married for 51 years
- 3 children
- 7 grand children
- 14 great grand children
- Retired for 15 years from Keebler Company and is still involved with retirees' organization.

The Skinny:

Dorothy went to work as a welder making trailers for the "war effort" during World War II. It was worthy work, but hard work, says Dorothy, and it "inspired her" to look for <u>other</u> employment! In 1946, after divorcing her first husband, Dorothy found herself raising 3 children on her own. With a family to raise, Dorothy made the decision to provide a better future for her family and for herself.

She went to work for Keebler Company (yes, the one with "Elfin Goodness") and began a long career with this company. Dorothy knew she also needed to determine a new direction in her life, and made the time to attend Business School at night while working full time during the day. She was rewarded with a promotion to the Human Resource Department where her, "... world of being involved with other business women began when my boss introduced me to a member of the International Association of Personnel Women." After she joined this group, she became acquainted and traveled with other members such as Dorothy McRae, Minnie Lundberg, Leota Pekrul, and Jackie Freudenstein, all who were members of Zonta Club of Denver!

After hearing these ladies talk about their experiences with Zonta, Dorothy became a member of the Zonta Club of Denver in 1982 with Minnie Lundberg as her sponsor! She attended her **first** convention in Sydney, Australia in 1984 where she watched women from around the world march

across the stage of the Sydney Opera House wearing native dress and carrying country flags with pride (doesn't this just give you goosebumps?). The world wide reach of Zonta International working to improve the status of women impressed Dorothy and she made the decision to become more involved to help accomplish Zonta's goals of helping women and children around the world.

In 1984, Dorothy became the club's first vice president and the president in 1986. Not stopping there she became the Area Director in 1988, and after a second close vote (the first was a tie) Dorothy became Lt. Governor under then Governor Dolores Lowery in 1990. Dorothy did not stop there either. In 1992, she was installed as District 12 Governor at the International Convention in Hong Kong. She still feels great pride (and deservedly so) for a job well done working with 2 successful District Conferences, area meetings and presiding over numerous club installations. At the Zonta International Convention in Detroit, Dorothy carried the District Flag at the opening ceremony (...again... goosebumps). Dorothy has continued to be involved with Zonta for the past 25 years and has attended conventions in Sydney, Australia; Toronto, Canada; Helsinki, Finland; Dallas, Texas; Hong Kong, China; Detroit, Michigan/USA; St. Louis, Missouri/USA; Paris, France; and Hawaii!

After her governorship, Dorothy says she experienced "empty mail box syndrome" as the plethora of "Zonta mail" stopped coming, but rather than standing still, she kept busy with her club, and frankly, haven't we all benefited from that?! Thank you Dorothy Swindt for all you have done and continue to do for the Zonta Club of Denver!

Challenges Facing Immigrant Women

An Introduction to the Cormal Heritage Food Incubator was

the beginning of an exploration into the experiences of immigrant women in our community and at large. Cormal offers lunches prepared by immigrant women who are receiving job training and education in the culinary arts and language skills. This project is the result of the collaboration between focus Points Family Resource Center and Zeppelin Development as community outreach. They originally stared with 15 Latina women from El Salvador, Mexico and Peru. Recently, they started an additional group of Syrian refugees in the program who recreate their native foods on Fridays. An additional goal was to 'bridge the gap between legacy and newer, trendy populations in the neighborhood."

In an article by the Center for American Progress, '10 Facts you need to Know About Immigrant Women (2013 Update)' trafficking and abuse, both domestic and in the work place are the most severe challenges,. The Justice Department estimates that 50,000 people are trafficked to the USS. Officials can grant 5,000 T-visas to help free immigrant women from the sex trade. However, in 2012 only 674 T-visas were granted. Potential isolation can make immigrant women vulnerable to partners who don't file their papers and/or threaten deportation as do some employers. According to the Applied Research Center, 5,000 children were living in foster homes due to parents being detained or deported in 2011.

Gratefully, there are several programs to assist immigrants and refugees such as the Latina Safehouse Initiative, which is holding a Golf Tournament to raise monies on June 23rd. In addition, Colorado.GrantWatch.com provides instruction in the English language and offers citizenship, and integration programs. Instruction in our laws is extremely important including the ones that may offer them protections. The Violence Against Women's Act allows immigrant women who have suffered domestic abuse by an American citizen or Legal Permanent Resident to self petition for legal residence.

In spite of the many challenges that these women face, including many that have not been mentioned, they start businesses at a higher rate than native born American women. In 2010 women were 40% of all immigrant business owners and 20% of women business owners in General!

Committee Reports:

Advocacy Committee - Mary Benoit

During last month's Zonta Meeting, the Advocacy Committee distributed Rose Andom Center brochures to be placed in discrete locations (for example -restrooms) in salons and locations where women go. The brochures provide information about the services provided by the Rose Andom Center and support victims of abuse. Members were encouraged to take more brochures and provide them to locations where women could access them and get the support they need.

Gwen Fornia reminded members that Zonta membership dues are due by May 1, 2017. The total amount for continuing members is \$194.00. The under 30 membership dues are \$125.00 for returning members.

For the May meeting, Liz Savage announced that there will be one belated installation of a member and there are three new applications for membership that will need to be approved by the board.

The Membership Committee is going to be looking at a new venue to for meetings – a restaurant called Rendezvous located at Heather Gardens. The Membership Committee is open to suggestions; however, there are set of criteria that must be met. Below is that complete list of questions that outlines the criteria:

- Can we order off the menu (as opposed to one meal for all or a buffet)?
- · Can we have separate checks for each person?
- · Is there ample parking that is reasonably close?
- · Does the room have a microphone/PA system, and a screen for presentations?

Fundraising Committee: Kathy Hyzer

On Saturday, May 20th, volunteers are needed starting at 6:30 AM. The day is divided into shifts – and the more of them you can work the better. All items that go unsold will be donated to the Salvation Army.

Julie Bradley announced that Regina Weinecke was born and Katie Weinecke is doing well.
